

President's Message

Child Guidance Center is fast approaching our 74th year in the Jacksonville community. With over seven decades serving the area, we have learned much about our residents.

We recognize how trauma affects not only the individual in the moment of the crisis, but also in their recovery and in their future development.

We recognize how important it is to consider all aspects of a person's health, including their physical, mental, emotional, financial, social, nutritional, relational, and spiritual health.

We know that as humans we are linked to others and that, especially within a family, it is imperative to include as many involved family members as possible in the work of the family unit.

The CGC Board of Directors continues to work at expanding our donor base. CGC hosted our fourth Annual Sandal, Sneaker & Stiletto Gala at San Jose Country Club. The paddle raises and live and silent auctions increased our fundraising. Our Board commits to raise money to ensure CGC continues to provide much needed mental and behavioral health services to our community.

CGC staff continue to provide our clients with excellent mental health services via face-to-face and telehealth. Qualified workforce demands continue to create staffing issues, specifically in our Outpatient program. A staffing pattern supported by Medicaid is difficult to sustain even with the funding increase received this past year. With the Outpatient client base primarily Medicaid funded, we are still unable to meet the higher salary demands of experienced staff. CGC's Strategic Planning Committee, Executive Team, and Management Team continuously review our HR practices to determine solutions.

Our Medical Team is exploring ways to serve clients despite the difficulty securing Psychiatrists. We employ 1 FTE Psych APRN at this time, who provides both in-person and telehealth services.

CGC continues to work closely with Duval County Public Schools (DCPS) through our Full Service School program as well as our 24/7 Rapid Response Team (RRT).

Our Community Action Team (CAT) continues to provide high intensity family treatment and has grown over the past several years to include a Little CAT program for younger children.

The CGC Outpatient program continues to serve clients throughout the Jacksonville community at our Westside, Northside and Southside locations; we also operate a small satellite office for young children in Clay County. We have decided to explore other locations at the Beaches at this time.

We continue to provide Targeted Case Management services but on a smaller scale due to a significant need for the state to increase Medicaid reimbursement rates for that service.

CGC continues to operate our Immediate Access Clinic to assist with urgent client care.

Community Action Team (CAT)

CAT consists of therapists, case managers, mentors, nurses and psychiatrists who provide wraparound services to high-risk children, youth and their families in Duval County.

Case Management Services

Targeted Case Managers work with the child and family to link them with needed community services, monitor, and evaluate the services. Case Management services are available in Duval County.

Full Service School Counseling

Counseling is provided at Beaches and Sandalwood High Schools, as well as all middle and elementary feeder schools. Individual, family and group sessions are provided.

Infant, Child & Family Therapy (Sulzbacher Village)

Provides on-site therapeutic services to the residential families of Sulzbacher Village.

Infant & Early Childhood Services

Services are provided to families with children under 6 who have been experiencing emotional and/or behavioral difficulties. Services include family therapy, individual therapy, play therapy, and case management. The specific services and location of services are determined by the family's needs. These services are provided in Clay and Duval Counties.

Outpatient Services

Outpatient counseling consists of individual and family therapy, group therapy, and parental support. This service is available to all children, adolescents, and families who meet clinical criteria.

Psychiatric Services

Psychiatric services can be accessed at all Duval County sites at Child Guidance Center. Clients are provided the following services: Psychiatric Evaluation, Team Treatment Planning, and Medication Management.

Rapid Response Team

This mobile response team's objective is to reduce the number of children hospitalized through the Baker Act and to ensure follow-up services are provided after the crisis intervention episode. Referrals are accepted from Duval County Public Schools, 988, and for anyone in the Duval County area.
